Dear Club President:

If your proposed candidate to receive the Massie Medal Award for Distinguished Achievement is chosen by the Massie Medal Committee, you will be notified by the Committee Chairman. Your assistance will be solicited to make certain the recipient attends the Annual Meeting and that confidentiality is maintained to assure that she and others do not know the name of the winner. If your candidate is not chosen, you will receive a letter from the Committee Chairman after the Annual Meeting.

The winner and her spouse, or a guest, will have their hotel room and banquet dinners paid for by the Garden Club of Virginia. Please contact the MMA Chairman with the following information:

- Number of family members who will be attending the banquet. PLEASE NOTE: family members' meals are not covered by the GCV. Family members' rooms are not covered by the GCV. The number of family members attending is determined by the host club.
- Any dietary restrictions for the banquet meal for the winner and guest.
